

Snowmobile/snowmobile safari Rental Agreement

It is required that the lessee is 18 years old or over and to hold a valid licence for snowmobiles or a driving licence for off-road vehicles. Snowmobiles may also be driven by those who have a Swedish driving licence or a tractor licence issued before Jan. 1, 2000. Those who have had their driving or tractor licence recalled after Jan. 1, 2000 must have a driving licence in order to drive a snowmobile. There is an additional price for fuel.

Snowmobile safari. A valid driver's licence (any category) or a tractor licence issued from Jan.1, 2000 gives you the right to drive a snowmobile if you are part of a group within the tourist industry, with no more than 10 people, which is led by a guide/leader along a route that has been determined by the leaders before the trip. As a foreign driver (within EES*), you have the right to drive a snowmobile in Sweden if you have that right in your home country. If you can not demonstrate this or if you come from a country outside EES, your only option is to be included in a group within the tourist industry or to possess a Swedish driving licence. *EES-countries are member countries of the European Union as well as Norway, Iceland and Liechtenstein.

The lessee is required to acquaint him/herself with the management and driving of the vehicle and take part in the inspection of the vehicle together with the lessor prior to the trip or rental period.

The lessee/driver is required to acquaint him/herself with, and comply with the rules for, driving a snowmobile, both the Swedish rules and regulations as well as local restrictions for snowmobiles.

Reckless driving or other abuse of the vehicle will terminate the lease immediately. The snowmobile is to be returned to the lessor in the same condition as it was at the beginning of the rental period, with the exception of normal wear and tear. The lessee will take full responsibility for the vehicle that it isn't damaged or gets lost during the rental period and is liable to pay compensation for any damages due to recklessness or neglect. The lessee is free of responsibility if the damage or loss is due to defects in the vehicle or it can be proved likely that the damage or loss didn't occur due to recklessness or neglect. Damages or reduced functionality of the vehicle have to be reported to the lessor immediately. A change of drive belt is allowed, but other damages/mechanical defects cannot be repaired without the lessors consent. In case of damage the lessee will be liable to pay compensation where the maximum of compensation (excess insurance) **is 15000 SEK**. If assistance/towing is needed a fine of 425 SEK/hour, taxes excluded, will be charged. Damages made by the vehicle from not obeying rules and regulations means full liability to payment for the lessee. The lessor disclaims all responsibility for events with rented vehicle outside the control of the lessor, for example mechanical defects or other damage. If servicing, repairs or damages result in a booked snowmobile not being available, the lessor is then free to choose another snowmobile and if possible equivalent to the booked snowmobile.
